



SISTER CLUB AGREEMENT

WHEREAS, the officers and members of the Rotary Club of Bali Nusa Dua under R.I. District 3420, Bali and the Rotary Club of Tokyo Kojimachi R.I. District 2580, Japan, firmly believe that the signing of sister-club relationship between the two clubs will encourage and foster the advancement of international understanding, goodwill and peace through a world fellowship of business and professional persons united in the ideal of service;

WHEREAS, the officers and members of the above-mentioned clubs likewise firmly believe that the establishment of sister-club relations between the two Rotary Clubs shall be a concrete step to discover new approaches in pursuing common efforts in undertaking club, community, professional, international, new generations, and polio service projects that will give life and meaning to the observance of Rotary;

WHEREAS, the officers and members of the two clubs has agreed to execute this AGREEMENT to document their above understanding and commitments;

NOW, THEREFORE, for and in consideration of the above covenant and agreement, the parties hereto agree as follows:

That, to implement and carry out the purpose and objectives of this AGREEMENT, both clubs shall endeavor to promote and develop mutual understanding, friendship and goodwill and to undertake joint projects as may be agreed upon;

That both clubs shall coordinate and cooperate with one another regarding projects and/or activities of mutual interests, including but not limited to a global grant project;

That both clubs shall encourage visitation either individually or in group;

That both clubs shall regularly exchange club publication and information pertaining to their Rotary activities;

That if feasible, upon mutual consent, at least once a Rotary Year, a joint meeting shall be held to commemorate the signing of this Agreement, the venue to be designated on an alternate basis or on a neutral place (including, but not limited to, on an online basis), with the concurrence of the Presidents of both clubs;


That both clubs are not restricted by this Agreement to sign sister-club agreements with other clubs, provided both clubs duly notify each other of such event;

That this Agreement shall be effective for a period of one (1) year from the execution hereof, and be automatically renewed for successive one (1) year term unless either of the clubs provides notice of non-renewal to the other at least thirty (30) days prior to the end of the initial term or any subsequent renewal term; and

That this Agreement may be terminated by either of the clubs by giving advance notice of at least thirty (30) days to the other party.


IN WITNESS WHEREOF, the President of both clubs, representing their respective clubs, have hereunto set their hands this 1st day of February, 2021.
